

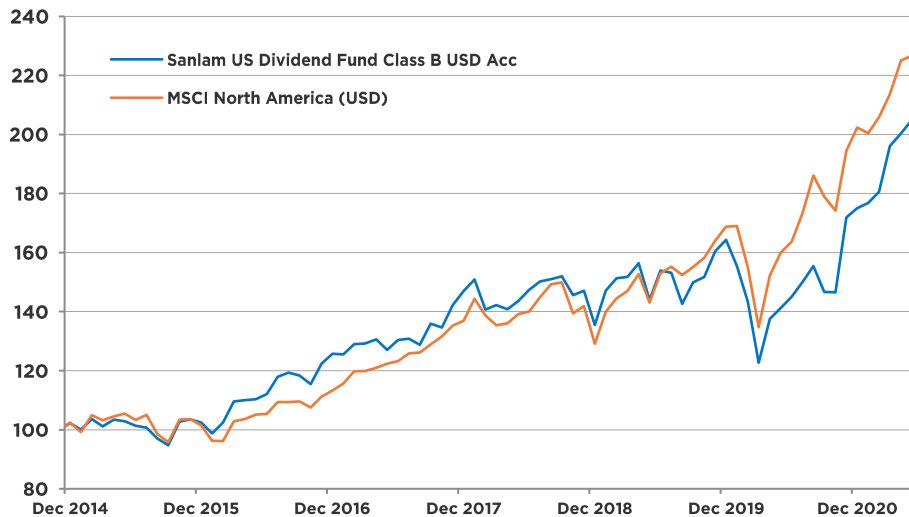
Sanlam US Dividend Fund

Overview

A dividend value fund investing in attractive US companies with the aim of achieving the highest risk-adjusted returns throughout the cycle against the benchmark. It has a value bias with a distinctive quality overlay, focussing on dividend sustainability and company valuation.

Monthly commentary

US markets added another 1% in May 2021, building on its strong run, which leaves the year-to-date return at circa 13%.

The value style of investment largely led the markets again in May, adding more than 2%. This brought the year-to-date value advance to 17%.

Markets were led higher by the financials, energy, materials and industrials sectors with consumer discretionary and technology sectors falling slightly.

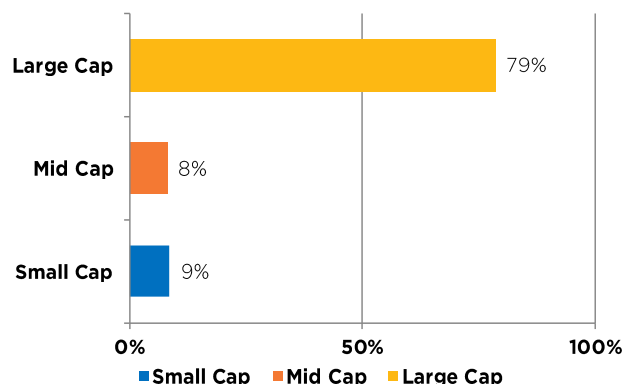
Commodities continued to act very well, as expected.

10-year treasury yields remained flat to down, between 160 and 150bps.

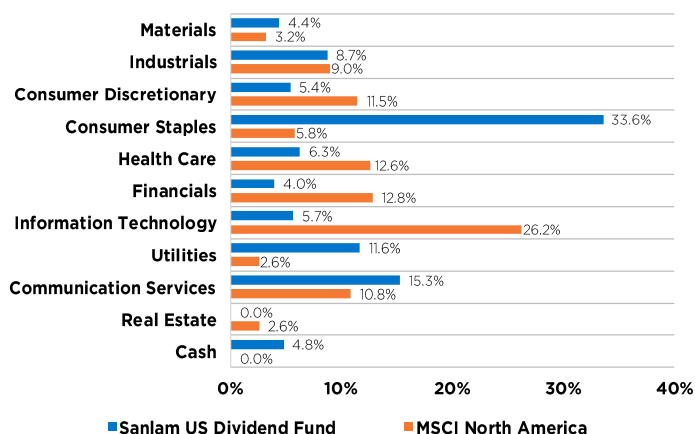
The fund advanced by around 2.2% this month and in the process slightly outperformed its value style, and strongly outperformed the markets. Stock selection drove the returns, particularly within communication services, IT, health care and staples.

The fund remained well positioned versus the market, offering a very good entry point into US equities. In addition, value lags the markets by wide margins. The valuation discounts remained anywhere from 45% to 70%.
