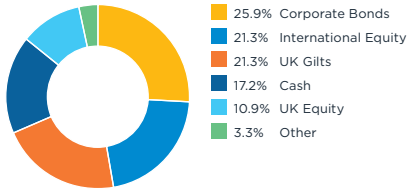

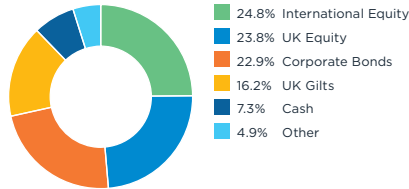

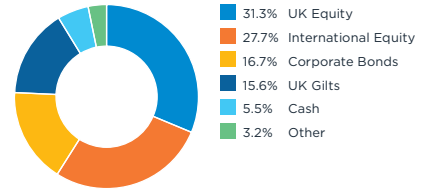
Yellow - asset allocation
