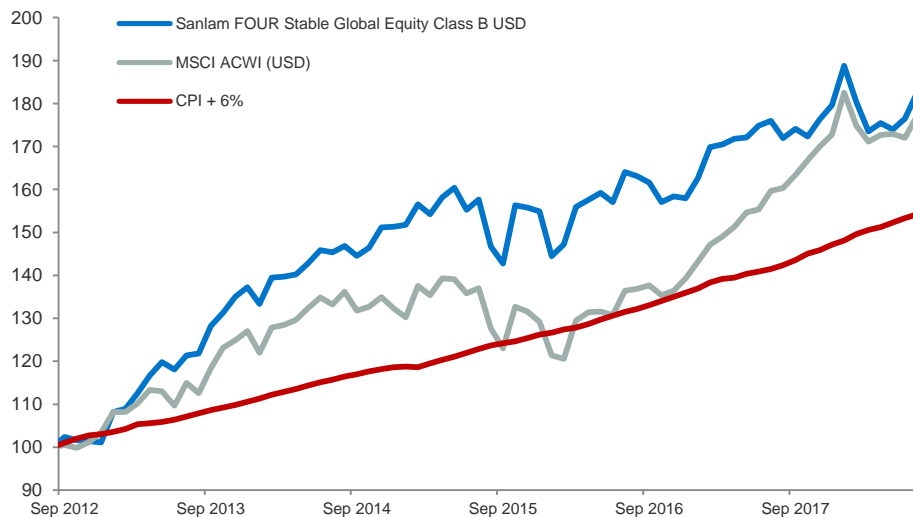


Overview

Aimed at delivering a long-term return of CPI+6%, the Fund invests only in quality businesses exhibiting strong and recurring cashflow to deliver superior risk adjusted returns over time. The team apply the disciplines of value investing to a subset of stocks exhibiting consistently high returns on equity and strong cash generation and are trading below their intrinsic value.

Monthly Commentary

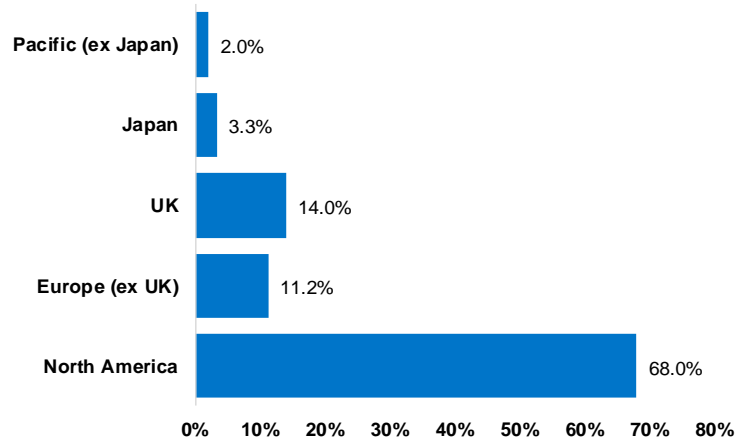
Global markets rose in the low to mid-single digits in USD terms, driven by both the US and European markets, bolstered by conciliatory trade talks and strong economic growth. As manufacturing ISM hit a new high, and Germany's IFO index and durable goods orders beat expectations, both the Fed and the ECB confirmed their commitment to raise rates. This positive sentiment was partly offset by the roll out of US tariffs against China and their retaliatory action; as well as the rapid slowdown in lending in China. Elsewhere, LATAM rebounded sharply with Brazil's economic data coming out much better than expected.

In this environment Industrials, HealthCare and Financials performed the best with Materials, Discretionary and IT lagging the overall market. The USD continued its climb, on the back of higher rates while the Oil price eased from last month's high to settle around \$72.

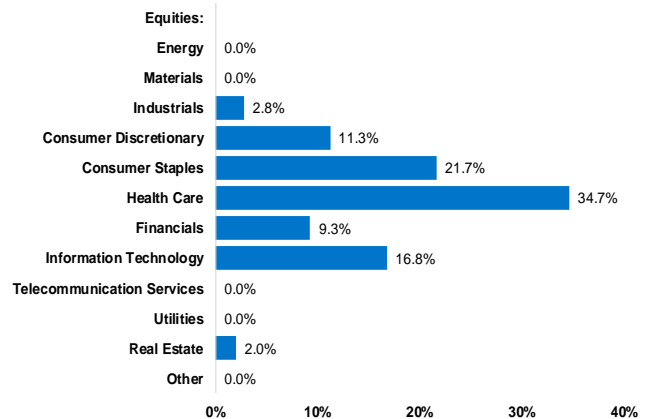
The Fund outperformed the market on the back of our stock selection in Healthcare, IT and Consumer Staples. Zimmer, Allergan, Roche, Oracle, Reckitt Benckiser and Microsoft were all outstanding contributors having posted good quarterly numbers. Zimmer in particular shone as its turnaround story gained credibility on the back of better manufacturing capacity of its key products, which led to better revenue and cash outlook. Oracle rebounded after investors digested the announced lower level of disclosure, revealing the company's more bullish expectations. Our latest investment, Reckitt, demonstrated an inflection in its segment fundamentals, as per our thesis, shrugging market concerns of long term headwinds.

We were also rewarded by avoiding large index fallers like Facebook and Netflix. The fragility of the growth assumptions underpinning their valuation seems to have caught up with them, at least temporarily. Conversely, the fund was held back primarily by eBay and Tupperware. eBay continues growing strongly but revealed adverse tax developments along with a slowdown in its StubHub unit. Nothing we are particularly worried about. Tupperware however lowered its guidance in the face of operational difficulties, which led it to shake up its management team, a problem which could be more long term in nature. We are actively re-evaluating this position.
